INCOME TAX AND CORPORATION TAX: DEDUCTION FOR EXPENDITURE ON

RESIDENTIAL ACCOMMODATION FOR CERTAIN STUDENTS

Part 11A provided for a scheme of tax reliefs designed to encourage the provision of residential accommodation for letting to third level students. As part of the codification of legislation governing relief, under various tax incentive schemes, for expenditure incurred in relation to residential accommodation, *Part 11A* was repealed by section 24 of the Finance Act 2002 and its provisions consolidated in *Chapter 11* of *Part 10*.
