- (6) Where a claim is being made by a person who directly or indirectly owns two or more qualifying small producers of other fermented beverages, which together produced not more than 10,000 hectolitres of other fermented beverages in the previous calendar year, and treatment as a single producer is requested, all producer names should be included.
