Other documents required

The Application should be **signed** by the Owner if a Sole Trader, by one of the Partners if a Partnership or, in the case of an Incorporated Firm by the Company Secretary or a Director of the Company.

If this Application is approved the Revenue Commissioners will issue you with an **Application Notice** to apply for the Licence, at which stage you will be required to declare that you hold in your **possession the following documentation (these will also be listed on the Application Notice):**

- 1. A valid **Tax Clearance Certificate** in the name of the Owner will be required to take up the Licence.
- If the Owner is a Limited Company, under Section 38(a) of the Intoxicating Liquor Act 2000

 a Duplicate Certificate of Incorporation dated not earlier than 4 weeks before the date of
 application, will be required to apply for the Licence. Duplicate Certificates of Incorporation are
 available at www.cro.ie. LoCall 0818 452 000 or 01 804 5200.
- If the Owner trades using a business name (i.e. the name over the door of the premises) which is not that of the beneficial owner of the business, under Section 38(b) of the Intoxicating Liquor Act 2000, a Certificate of Registration of the Business Name will be required to apply for the Licence. Duplicate Certificates of Registration of the Business Name are available at www.cro.ie. LoCall 0818 452 000 or 01 804 5200.
- 4. The operator of a Passenger Vessel is required under the **Merchant Shipping Act 1992 (as amended)** to hold:
 - a Passenger Ship Safety Certificate for the Irish Passenger Ships carrying more than 12 passengers, or
 - a High Speed Craft Safety Certificate for Irish High Speed Crafts carrying 12 passengers or more, or
 - a Passenger Boat Licence for vessels carrying less than 12 passengers.

- 5. The Owner of the vessel is required to provide Evidence of Proof of Ownership this can be:
 - a Certificate of Registration under the Mercantile Marine Acts 1955, or
 - a signed declaration with regard to ownership will be required for vessels under 15 tonnes where a Certificate of Registration under the Mercantile Marine Acts is not held.
