Introduction

In October 2015, Revenue published *The Farming Sector in Ireland: A Profile from Revenue Data* which presented a statistical analysis of farmers from the perspective of Revenue data (available at <https://www.revenue.ie/en/corporate/information-about-revenue/research/statistical-reports/sectoral-reports.aspx>). Subsequent annual publications have updated the key tables of that report. This present report revises and updates the statistical tables for 2018 and 2019 (where available).¹
