## Schedule of Updates for Revenue Statistics

This calendar records the planned publication dates for Revenue Statistics. Statistics are categorised by publication frequency: monthly, quarterly and annual or bi-annual.

For each statistical release, the reference period and issue dates are shown. In most cases, the issue date is indicated as not later than ("nlt") a given day in the month.

This Schedule will be updated monthly and the update published on the Revenue Statistics website on the 15th of each month.

In each following month, the timeliness of releases in the previous month will be shown by colour code:



The last column on each page below identifies if that publication, and the data contained within it, have been designated as 'Official Statistics' and have been deemed compliant with the Irish Statistical System Code of Practice (ISSCoP).
