# **Explanatory Notes**

# On completing the Discrepancy Notice (DN) form

- 1. Each DN form should be used to record discrepancies related for one trust only.
- 2. The relevant trust is a reference to the trust that this notice relates to. Please enter the name and the trust registration number of the relevant trust.
- 3. Name of Designated Person (i.e. organisation or individual) delivering the Discrepancy Notice.
- 4. Details of individual who has formed the opinion that there is a discrepancy and details of the individual delivering the DN to the Registrar.
- 5. Please indicate the name(s) of each beneficial owner(s) of the referenced trust, in respect of whom a discrepancy report is being made and the nature of the discrepancy. Please also outline in each case, the basis for the Designated Person forming the opinion that there is a discrepancy between particulars that have come to the Designated Person's attention and information held in the CRBOT (Regulation 22(3) of SI 194/2021 refers).

# Definition of a Beneficial Owner

The definition of a beneficial owner in Article 31 of the Fourth Money Laundering Directive was inserted into Part 4 of the 2010 Criminal Justice Act by the Amendment Act 2021. "Peneficial owner" in relation to a relevant trust, means any of the following:

"Beneficial owner", in relation to a relevant trust, means any of the following:

- (a) any individual who is entitled to a vested interest in possession, remainder or reversion, whether or not the interest is defeasible, in the capital of the relevant trust property;
- (b) in the case of a relevant trust other than one that is set up or operates entirely for the benefit of individuals referred to in subparagraph (a), the class of individuals in whose interest the trust is set up or operates;
- (c) any individual who has control over the relevant trust;
- (d) the settlor;
- (e) the trustee;
- (f) the protector

# Central Register of Beneficial Ownership of Trusts ("CRBOT")

The Central Register is the Central Register of Beneficial Ownership of Trusts as per Regulation 21 of SI 194/2021.

# Registrar

The Registrar is the Registrar of Beneficial Ownership of Trusts as per Regulation 20 of SI 194/2021.

## **Relevant Trust**

A Relevant Trust within the designated meaning in the Criminal Justice Act of 2010.

## **Designated Person**

The meaning of "Designated Person" is outlined in Section 25 of the Criminal Justice (Money Laundering and Terrorist Financing) Act 2010, as amended.

## Discrepancy

Regulation 22(3) of SI 194/2021 states that if any Designated Person forms the opinion that there is a discrepancy between the information relating to a relevant trust in the central register (CRBOT) and the beneficial ownership particulars available to the designated person relating to the trust, the designated person shall deliver to the Registrar, in a timely manner, notice of that opinion specifying the particulars of the discrepancy.

Only material factual differences should be reported – a minor variation in a name (e.g. Patrick versus Pat) or an insignificant spelling / typographical error would not be considered a material difference.

Where an Irish version of a name is used this name must correspond to what has been entered in the internal register. If different language versions of a beneficial owner's name are found between the internal register and CRBOT then this is regarded as a discrepancy.

#### **Data Protection**

The Data Protection Act 2018 (No.7 of 2018) is specifically referenced in Regulation 27(7) as applying to the access that the Registrar affords to a designated person and any other person in respect of the information in the central register that relates to a relevant trust.

Designated Persons should know their obligations and responsibilities in how they collect, use and protect personal data in line with Data Protection legislation.

SI 194 of 2021 assigns to the Revenue Commissioners the task of hosting and maintaining Ireland's Central Register of Beneficial Ownership of Trusts. Revenue requires trustees or their agents, advisors, or employees to provide certain personal data in line with this SI.
