The European Union has adopted a package of sanctions, <u>Council Regulation (EU) 2022/355</u>, in view of the situation in Belarus.

The Regulation introduces prohibitions on the import and export of certain products to/from Belarus or originating in Belarus.

Imports

The Regulation prohibits the import, directly or indirectly, of:

- Wood products as listed in Annex X
- Cement products as listed in Annex XI
- Iron and steel products as listed in Annex XII
- Rubber products as listed in Annex XIII

into the Union if they originate in Belarus or have been exported from Belarus.

These prohibitions do not apply to the execution until 04 June 2022 of trade contracts concluded before 02 March 2022, or of ancillary contracts necessary for the execution of such contracts.

Exports

The Regulation prohibits the sale, supply, transfer or export, directly or indirectly, to any natural or legal person, entity or body in Belarus or for use in Belarus of the following:

- Machinery as listed in Annex XIV
- Dual-use goods and technology which might contribute to Belarus's military and technological enhancement or the development of the defence and security sector, as listed in Annex Va
- The Regulation also extends the existing controls on dual-use goods and technology, as provided for in <u>Council Regulation (EU) 2021/821</u>, to all end users (previously only applied to military end users) in Belarus

These export prohibitions shall not apply to the sale, supply, transfer or export of machinery and dual-use goods and technology or to the related provision of technical and financial assistance, for non-military use and for a non-military end user, intended for:

- (a) humanitarian purposes, health emergencies, the urgent prevention or mitigation of an event likely to have a serious and significant impact on human health and safety or the environment or as a response to natural disasters
- (b) medical or pharmaceutical purposes
- (c) temporary export of items for use by news media
- (d) software updates
- (e) use as consumer communication devices

How to avail of exemptions

In order to avail of the exemptions listed above the declarant should enter the relevant code in Data Element (D/E) 2/3 of the customs declaration or Box 44 of the SAD in the case of exports. The relevant codes are listed below:
