Revenue is making some system changes to AIS in a release which will go live during the week commencing **16 May 2022.** This release will be available in our test environment (PIT) from **12 May 2022.** We will give five days' advance notification of the go-live date.

This release will introduce technical changes. The technical changes will not require you to provide any additional or new data but will result in the stricter application of some business rules, causing some declarations to be rejected. It is important that you understand and are ready for these changes.

The main changes are highlighted below with full details to be found in the Annex

If you are an **Importer, Declarant or an AIS Software Provider**, you should take note of the following:

Use of Relief Codes C07, C08 & 1C1 across the H1, H6 and H7 declarations.

 Where you are claiming a reduction in, or relief from, the payment of duties, the validation rules around the combination of codes to be used have been fully implemented in line with the relevant legislation. Where you declare the incorrect combination of codes, your declaration will be rejected.

Once-off application for the use of the Procedure of Temporary Admission, End – Use, and Inward Processing.

 There are new rules for once-off applications from traders for the use of the above procedures. The 8f dataset must now be completed in the customs import declaration (IM415 message). Details of the dataset and the validations and business rules are provided in the Annex.

Refunds and Invalidations

- The commodity code field will no longer be validated when it is declared on a Deposit Refund Application (RD415) meaning that if you include it your declaration will not now be rejected.
- The declarant identification (EORI) number will now be mandatory on all Invalidation Request messages (IM414). Failure to provide this number will result in the Invalidation Request being rejected.

Quota Deposit

• Where you submit an import declaration that has a quota claim and where quota was allocated and you subsequently submit an amendment where the data elements in relation to the quota details have not been changed, AIS will **no longer** take a deposit. This will be the case even if the quota status has moved to critical.

Simplified Declaration followed by Supplementary Declaration

Currently, AIS will reject a supplementary declaration in cases where the exchange rate has
changed between the date of submission of the simplified declaration and the date of
submission of the supplementary declaration. Rejection of such supplementary declarations
will no longer happen.

Importation of excisable product under duty suspension to a tax warehouse

- AIS and EMCS are being developed to communicate with each other electronically. AIS will
 automatically confirm that a national movement in EMCS has been created before the goods
 being imported are released. When this change goes live it will remove the current manual
 procedure where you are required to email documentation to the import stations at our
 ports and airports in advance of the goods being released.
- In preparation for the integration of AIS and EMCS the following new business rules have been included in this release (BR700001, BR700002 and BR700003.) These will not be switched on until a later date. Further information in relation to the rules is provided in the Annex.

(1) Enhancements and Fixes:

The following updates will be deployed as part of this release:

• RD415 Submission:

BR0020 will no longer validate the Commodity Code field where it is declared on a Refund Deposit application (RD415).

• Hx Supplementary declaration rejecting due to exchange rate:

The validation of the HX (IMY) exchange rate will now correctly calculate on the date of acceptance of the Simplified Declaration (I1) and will no longer be rejected with BR8610.

Behaviour of BR5153:

Where 00100 in DE2/2 is declared, AIS will now require that the application for authorisation (8f) is completed. Please note that the code in DE 2/2 00100 and the 8f dataset can only be declared in an IM415 declaration.

• IM414 Invalidation Request being accepted without DE 3/18 Declarant Identification Number:

DE 3/18 Declarant Identification number is a mandatory field and is required in all IM414 messages. If omitted, the declaration will be rejected.

• Update to Message Exchange Document:

Section 5.2.2 Pre-lodged Standard Customs Declarations' scenario has been updated to take into consideration that an IM416/IM451 messages can also be issued pre-Acceptance if there is a Tariff Validation error.

• Quota Deposit taken on submission of IM413 amendment:

Where an amendment is submitted for a declaration that has a quota claim and where quota was allocated and data elements in relation to the quota details have not been changed, AIS will no longer take a deposit even if the quota status has moved to critical.

1D3 Quota Deposit amount not included in message IM493 Amendment notification for partial or deferred quota allocation:

This will now show correctly in the IM493 message type.

How to use Relief Codes C07, C08 and 1C1 across the H1, H6 and H7 declarations:

H1 Declarations:

- The combination of 1C1 and C08 is allowed but only in different items.
- 1 item declaration: where C08 is declared and DE 8/6 statistical value of the item is over €45 then the declaration is rejected.
- Multi item declaration: where C08 and 1C1 are declared the total value of C08 items must not exceed €45 and the total value of the 1C1 items must not exceed €700 then the declaration will be rejected.
- Where C07 is declared on a H1 and the total value is greater than €150 then the declaration is rejected.
- o The combination of C07 and C08 is not allowed.
- o The combination of 1C1 and C07 is not allowed.

H6 Declarations:

- o The combination of 1C1 and C08 is allowed but only in different items.
- 1 item declaration: where C08 is declared and the sum of the customs value (sum of DE '4/18 Value' plus DE '4/19 Transport costs to the final destination' which is divided equally across all the items)) of one item is over €45 then the declaration is rejected.
- Multi item declaration: where C08 and 1C1 are declared the total value of C08 items must not exceed €45 and the total value of the 1C1 items must not exceed €700 then the declaration will be rejected.
- Where C07 is declared on a H6 and the total value is greater than €150 then the declaration is rejected.
- The combination of 1C1 and C07 is not allowed.
- The combination of C07 and C08 is not allowed.

H7 declarations:

- Where C08 is declared in one Item, it must be declared to all Items.
- One item declaration where C08 is declared and the sum of DE '14 14 000 000 Intrinsic Value' plus the DE '14 15 000 000 Transport and insurance costs to the destination of one item is over €45 then the declaration is rejected.
- Where C07 is declared and DE 4/14 item price (14 14 000 000 intrinsic value) is over €150 then declaration is rejected.
- o Relief code 1C1 is not allowed.
- The combination of C07 and C08 is not allowed.

 Requirement where an 8f once off application for the use of temporary admissions, end-use and inward processing, in situations where Article 163 applies:

Where the following information is declared then the 8F data set must be completed.

- o DE'1/10 Procedure Code' of IM415 H1 is '44' or
- o DE'1/10 Procedure Code' of IM415 H3 is '53' or
- o DE'1/10 Procedure Code' of H4 is "51" AND
- o DE 2/2 contains 00100 dataset 8f is applicable.

There are several additional validations that will be in place which cover the status requirements for Data Elements within the 8f application and include several new business rules.

Integration between AIS and Excise Movement Control System (EMCS):

The integration functionality will not be enabled in this release. It will be enabled on a future date, and the related new business rules (BR700001, BR700002 and BR700003.) will be disabled in the interim. A further notification will issue in advance of this new integration becoming operational.

Where goods are being declared on a H1 under procedure code 07 (free circulation simultaneously placed in a warehousing procedure where VAT and Excise duty have not been paid) and the warehouse number declared in DE 2/7 starts with 'IETW', then there must be an ARC number (1D12) in DE 2/3.

The AIS declaration will be rejected where:

- o the ARC number is not present,
- the ARC number is not related to the warehouse number declared on the AIS declaration, and
- o the ARC number is not in an accepted status.

H1 Declarations:

Where the Procedure code (DE 1/10) is 07 (Release of goods for free circulation simultaneously placed under a warehousing procedure other than a customs warehousing procedure where neither VAT nor, when applicable, excise duties have been paid) and a Warehouse number declared (DE 2/7) that starts with 'IETW' then there MUST be an ARC number (1D12) present (DE2/3).

The ARC number must follow the format (N2) (A2) (AN16) (N1), and the ARC number must be declared at Header level in DE 2/3 with code 1D12 (Administrative Accompanying document reference number (ARC)).

The ARC number must be in an accepted status and correlated to the warehouse number declared on the AIS declaration, otherwise the declaration will be rejected.

Amendments:

The declarant is permitted to amend a declaration that contains an ARC number; however, they are not permitted to amend the following data on the declaration:

- o ARC number,
- Warehouse ID.
