### **AIS Trader Support**

- ➤ March 2020: Letters issued to Air & Sea Carriers, Express Carriers, TSF Operators and Customs Agents
- ➤ May 2020: 17,370 letters issued to regular importers informing them about AIS and telling them to contact their customs agent.
- ➤ AIS information is on the Revenue website. This includes narrated presentations for Customs Agents, TSF operators, Air and Sea Carriers, Express Carriers and Parcel Operators.
- ➤ August 2020: Twitter being used for the AIS message.
- August 2020: Revenue's Brexit readiness article, which included information on AIS issued to trade bodies including IBEC, IEA, Enterprise Ireland, SFA, LEOs for circulation to their members

### **AIS Trader Support**

- September 2020: Skype for Business presentations on the impact of AIS on TSF operators. Further S4B presentations will take place in September and October.
- > Dedicated email address for AIS Queries <u>ucc-cmu@revenue.ie</u>
- The UCC Change Management Unit is operating an 'opt in' mailing list to update traders of any new AIS changes coming their way.
- >One to one meetings give Revenue an opportunity to provide targeted AIS information and to answer AIS questions. In the coming months this engagement will target Brexit traders.

### AIS – Main Messages

- ➤It will not be possible to complete customs import formalities in respect of third-country goods into Ireland from 9am 2/11/20.
- >AEP for imports will be gone.
- Everyone in the import supply chain needs to take action. This may mean making sure customs software is updated or contacting a customs agent to make sure they are ready.
- ➤ The structure and content of the customs import declaration is changing the Import SAD is gone and replaced with a new declaration type.

### **AIS – Main Messages**

- To help the trade we have the AIS Trader Guide to help you to become familiar with the new data elements which replace the boxes on a SAD.
- Supply chain communication is critical as there is a requirement to reference the previous document information on each declaration that is submitted.
- All Revenue staff with responsibility for customs functions are being trained to use AIS. This will ensure that Revenue continues to facilitate trade and manage post clearance interventions effectively and efficiently.
