Session One 9.00 – 09:20

Theme: Customs Overview – Brexit changes and what they may mean for you

This will be a keynote address by Revenue Commissioner, Mr Gerry Harrahill.

Session Two 9.35 – 10:10

Theme: Import – Air and LoLo. Importing your goods by sea or air

This session will be led by Revenue and will take you through the import requirements for goods arriving into Ireland from Great Britain. It will outline the requirement to complete Safety and Security declarations, Presentation Notifications and Temporary Storage declarations.

It will emphasise the need for sharing of declaration information throughout the supply chain to allow for import declarations to be completed. A sample journey will be presented to demonstrate end to end requirements. It will include some key elements of the Automated Import System (AIS) which will become operational in November 2020.

The presentation will be followed by a Q&A session.

Intended audience: Businesses that will be importing products from Great Britain from 1 January 2021; business logistics managers; Hauliers; Freight forwarders; Logistic companies; sea and air carriers; customs intermediaries.

Session Three 10:25-11:20

Theme: Import – RoRo. Importing your goods by ferry

This session will be led by Revenue and will take you through the new Customs RoRo Service application which has been designed to facilitate, to the maximum extent possible, the 'just in time' delivery model.

This session will illustrate what you need to do in advance of boarding, how to check your customs channel in advance of disembarkation and check-in at the customs compound if called for a customs or Sanitary and phytosanitary (SPS) check.

It will show the process of goods being cleared at the port (either normal transit or standard release for free circulation) and goods moving under transit to a Temporary Storage Facility. It will include some key elements of the new Automated Import System (AIS) which will become operational on 2nd November 2020.

A sample journey will be presented to demonstrate end to end requirements.

The presentation will be followed by a Q&A session.
