Introduction

From 01 January 2021, all goods arriving in Ireland by RoRo ferry from a place outside the customs territory of the EU, must be imported in accordance with Section 12B of the Customs Act 2015, as inserted by Section 88 Withdrawal of the United Kingdom from the European Union (Consequential Provisions) Bill 2020.

This means that for inbound movement, all safety and security, customs declarations and transit declarations must be lodged prior to arrival at the ferry port of departure in the third country. Additionally, the Movement Reference Number (MRN) of the aforementioned declarations for all goods carried on a vehicle or trailer, must be included in a Pre-Boarding Notification to be submitted to Revenue prior to the arrival of the goods at the ferry port of departure in the third country. For outbound movements the MRN(s) for all of the goods carried on a vehicle must be included in the PBN submitted and cleared by Revenue prior to the departure of the goods from the ferry port in Ireland.

Failure to comply with this requirement is an offence, punishable on summary conviction of a fine of €5000 or imprisonment for a term not exceeding 12 months or both.

A PBN will be required even for all commercial vehicles or trailers even where they are empty.

What is a Pre-Boarding Notification (PBN)?

A PBN is an electronic envelope into which details of all the declarations or movement types for all the goods on the vehicle are input to ensure:

- that no goods are landed in Ireland from a third country without being in a customs procedure.
- to enable allocation of a channel to this vehicle on disembarkation from the ferry in Ireland:
or
- to verify the exit of goods from Ireland.

Who must complete a PBN?

A PBN must be created and completed by the carrier in respect of each commercial vehicle or trailer. For the purposes of completing the PBN 'carrier' means a person who has assumed responsibility for carriage of a relevant shipment or an empty vehicle, or the effecting of a relevant movement in relation to goods, into or out of the State by ferry and includes a person who provides haulage services or logistical services in relation to any of the foregoing matters.

What must be included in the PBN?

The PBN must contain the MRN(s) for the declarations related to the goods being carried on that vehicle or the details of the relevant movement types where an MRN is not relevant. To note, there is only one PBN per vehicle or trailer is permitted even where multiple consignments are carried in the vehicle or trailer. It is possible to include multiple MRNs in the PBN.

When must the PBN be completed?

The completion of the PBN must be completed in advance of the vehicle/trailer being checked in at the ferry port of departure in the third country (GB) for inbound movements into Ireland or the ferry port of departure in Ireland in the case of outbound movements from Ireland.

For ease of reference this guide has been split into three sections:

- Section 1 outlines the scenarios for Inbound PBNs/RoRo movements?
- Section 2 outlines the scenarios for Outbound PBNs/RoRo movements
- Section 3 outlines the scenarios that are common to both inbound and outbound RoRo movements.

Section 1

Creating a PBN for goods coming into or going through Ireland from GB (Inbound PBN)

What type of MRNs are accepted in an inbound PBN?

The following MRNs may be included in an inbound PBN:


- AIS Import Declaration for goods being cleared at the port
- ENS Declaration
- Transit Declaration

The following MRN formats may be included in a PBN:


- ***AIS Import Declaration format is as follows;***
18 Characters starting with starting with the year country code and office of entry for example 20IEDUB100 followed by 1 alpha character, 3 numeric characters, 1 alpha character, 1 numeric character, alpha character "R" and 1 numeric character
- ***ENS Declaration format is as follows;***
18 Characters starting with 20IE followed by 14 numeric characters
- ***Transit MRN***
18 Characters starting with Two-digit year code, two character country code 20GB followed by 14 alpha numeric characters

How to create a PBN for an import declared on an electronic import declaration

On the RoRo (www.revenue.ie/roro) page click on **“Create PBN”**



For T1 Transit there may be either of the following situations.

1. A Vehicle with T1 Transit (Non-Union goods only) where the transit is **ending in the Port** and customs clearance is conducted at the port. In this scenario the PBN should contain the following information:
 - MRN of all the ENS declaration(s)
 - MRN of all the transit declaration(s)
 - MRN of all the Import declarations
2. A Vehicle with a T1 Transit (Non-Union goods only) where the transit is **ending at an authorised Temporary Storage Facility (TSF)** and the goods are moving into another customs procedure should have at least the following information in the PBN.
 - MRN of all the ENS declaration(s)
 - MRN of all the transit declaration (s)

Note: The MRNs of import declarations are not to be included in the PBN in this scenario.

- At 30 minutes out from arrival of the vessel into Ireland, when the vehicle channel becomes available, Revenue will
- Issue a text message with the channel to the mobile phone number(s) in the PBN; and
- Issue an email with the channel to the email address in the PBN

When the channel for a vehicle is updated from 'Call to Customs' to 'Exit the Port', Revenue will notify this updating of the channel to:

- The mobile phone number(s) by text and
- The email address(es) by email.

This text messaging is in addition to the messaging that will issue by Revenue to the driver's mobile number when they are parked up and have used the Revenue Parking Self-Check-In. The text messaging associated with this function is mainly used to advise the driver electronically of where to go for inspection.

Creating a PBN for goods leaving Ireland to go to or through GB (Outbound PBNs)

What type of MRNs are accepted in an Outbound PBN?

The following MRNs may be included in an outbound PBN:


- AES export Declaration from 21st March 2023
- EXS declaration
- Transit declaration

MRN formats accepted into an outbound PBN

- **AES Export declaration format is as follows;**
18 Characters starting with 23IEDUB4 with the penultimate character indicating the declaration type.
- **EXS declaration format is as follows:**
18 Characters starting with 20IEDU1ES followed by 9 numeric characters
- **Transit declaration format is as follows;**
18 Characters starting with Two-digit year code, two-character country code 20GB followed by 14 alpha numeric characters



What type of Authorisation numbers/Reference Numbers are accepted in the PBN?

Authorisation numbers provided by Revenue in relation to the use of oral declarations for empty/returned packaging and piggyback trailers may be included in the PBN. Please access this link [Import and Re-import packaging](#) for further information on the authorisation process for empty packaging.

The CN37 reference number for postal movements can also be inserted into the designated field to create a PBN for a postal movement.

A valid ATA Carnet number can be inserted into the designated field to create a PBN for a movement covered by an ATA carnet.


How to create a PBN for an empty vehicle/trailer

A PBN ID is required for all empty vehicles checked in on a RoRo ferry as commercial freight. This can include all the following:


- Empty trailer
- Empty vehicle
- Empty van
- Cab
- Caravan
- Piggyback trailers (empty/stacked trailers, where a trader is not authorised by Revenue)




If you are moving empty trailers in a stacked or 'piggyback' manner by RoRo ferry, you can apply to Revenue for an authorisation number which can be used to create a Pre-Boarding Notification (PBN).

The '[Piggyback' trailer authorisation application form](#) should be completed and submitted to RoRoNCH@revenue.ie or Rosslare@revenue.ie. Revenue will process completed applications and, if approved, an authorisation number will issue to the applicant. The applicant will be required to accept the terms and conditions of the authorisation.

The approved authorisation will allow traders to create a PBN and move ‘piggyback’ trailers into, or out of, Dublin and Rosslare ports, on an ongoing basis.

Inbound Empty Packaging

If you are carrying empty packaging, there are two options available to you, outlined below.

Option 1: Authorisation for Oral Declaration

Businesses who frequently move empty packaging and containers into Ireland are advised to apply for an authorisation to move these items without having to present a declaration form to customs for each movement. The application form available at this link '[application form for oral declaration authorisation](#)' should be completed and sent to customsreliefs@revenue.ie for approval. Once authorised, the applicant will be issued with an Authorisation Number.

Once authorised:

- the business should, when creating a PBN, declare the authorisation number in the relevant field on the 'Create PBN' screen.
- these PBNs are given an automatic 'Exit the Port' channel

Option 2: Use of an Oral Declaration

Where a business does not hold an 'Authorisation for Oral Declaration' then an 'oral declaration' is required for each consignment, this requirement can be fulfilled at the time of requesting a PBN ID for the consignment.


The request for the PBN ID must include details of the goods being imported or exported i.e., the details supplied in the e-mail to Revenue can act as an Oral Declaration. It is important to check your channel to see if it is necessary to 'Call to Customs' to have your consignment checked and cleared for import. In the case of outbound PBNs created for oral export declarations you should check the status of the PBN. If the status displays 'Good to proceed to check-in' the driver can proceed to check in with the Ferry Operator.

Prior to boarding the ferry, the business must:

- email customspbn@revenue.ie and request a PBN ID for the movement of empty packaging by oral declaration
- All relevant details of the consignment are to be included in the email to customspbn@revenue.ie
- thirty minutes prior to arrival in the port, the channel should be reviewed on the 'Customs Channel look up' on the Revenue website




Can I edit my PBN after check-in at the ferry terminal?


How do I check my PBN Status?
