6.0 Lesson Introduction

6.1 Retrieval Practice

Activity 1

The teacher displays PowerPoint slide 3 showing a retrieval practice activity for the students to complete in groups. In this activity, each student records their answers on Unit 5: Student Activity Worksheet 1, Activity 1 and notes the time they finish the task. Students swap their answers and correct them based on the answers shown by the teacher. The student(s) who answer the most questions correctly in the fastest time win(s) the game.

6.	What do the letters TCC mean?	Tax Credit Certificate
7.	In what month does the Revenue Commissioners issue the TCC?	December
8.	What do the letters PRSI mean?	Pay Related Social Insurance
9.	What do PRSI contributions fund?	Social Insurance Fund, e.g. Maternity Benefit, Illness Benefit, Jobseeker's Benefit, State Pension, Dental benefits
10.	How many PRSI classes exist in Ireland?	11
