The fuel grant may be claimed up to annua maximum of 2,730 litres in respect of a driver or passenger, and up to 4,100 litres in respect of an organisation The Fuel Grant form is being processed for the Minister for Finance by the Office of the Revenue Commissioners. Payments will be made by the Department of Finance following the processing of the Fuel Grant form by Electronic Fund Transfer
