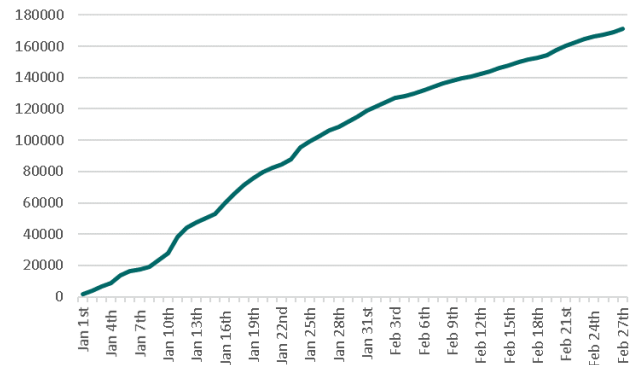


Save the Date Statistics & Economic Research Seminar 29 June 2023

Statistics Spotlight

PAYE Statistics from Income Tax Returns – incorporating the Rent Tax Credit

Budget 2023 announced the introduction of a new Rent Tax Credit, available for the years 2022 to 2025.

This new statistical report provides a breakdown on the number of Rent Tax Credit claims (total in chart above) and also notes the significant increase in the number of taxpayers filing their Income Tax returns since the introduction of PAYE Modernisation in 2019, leading to much earlier finalisation of tax positions and increased tax refunds where appropriate.

Selected statistics on rent tax credit:

- The median income of claimants is €30-40k
- 54% of claims are made by those aged 25-34
- 89% of the tenancies are registered with the Residential Tenancy Board; 11% are 'digs'
