eCommerce Developments (removal of de minimis and the proposed handling charge)	<p>Update provided by Andrew Clarke, Risk and Compliance Policy Branch.</p> <ul style="list-style-type: none"> <li>• A presentation was given by Andrew Clarke on the removal of the de minimis threshold of €150 and the proposed handling charge, this presentation has been shared with members of the CCC.</li> <li>• David Tuohy, eCustoms Branch, gave an update in relation to outreach and trader engagement which will commence when the changes are signed off. This is expected in the next couple of weeks.
