## **1** Introduction

## 1.1 Purpose

The purpose of this document is to describe the information (messages) Traders will be exchanging with the Revenue Commissioners.

This document is divided into the following functional areas:

- Entry of Goods
- Temporary Storage
- Import Release for free circulation
- Import Special Procedures
- Import Controls
- Import Refunds
- Import using Centralised Clearance

For each functional area, the document contains:

- A Sequence Diagram describing the messages exchanged between Traders and the Revenue Commissioners at a logical level, this excludes technical details.
- Declaration state transition diagrams. Where possible, state transition diagrams have been included that show all possible states that a declaration can acquire during processing and the action/messages that cause the transition.
- Summary Use Cases that describe the possible flows






### 3.2 Use Cases

- 3.2.1 Placement under Temporary Storage and Monitoring
- 3.2.1.1 Receipt of Temporary Storage Declaration and Presentation Notification, combined (G4+G3)







#### Core Flow (Happy Path) - Receipt of Temporary Storage Declaration and Presentation Notification, combined

- 1. AIS receives an TS315 (G4+G3) message
- 2. TS315 (G4+G3) is syntactically valid
- 3. TS315 (G4+G3) is logically valid (No business rules violation)
- 4. AIS sends TS315V (including the MRN)
- 5. The G4 + G3 declaration status is set to [REGISTERED]
- 6. AIS checks the arrival status of the declaration
- 7. The declaration is arrived
- 8. AIS forwards a TS328 registration message to the Trader
- 9. The G4 + G3 declaration status is set to [ACCEPTED]

#### Alt 1 - TS315 (G4+G3) is syntactically invalid

- 1. The process follows the core flow up to step 1
- 2. A TS315 message is syntactically invalid
- 3. AIS forwards an IM917 Syntax Error Notification message to the Trader


#### Alt 2 - TS315 (G4+G3) is logically invalid

- 1. The process follows the core flow up to step 2
- 2. A TS315 message is logically invalid (Business rules violation)
- 3. AIS forwards a TS316 rejection message to the Trader
- 4. The G4 + G3 declaration status is set to [REJECTED]


#### Alt 3 – Not arrived declaration

#### Core Flow (Happy Path) - Receipt of pre-lodged TSD

- 1. AIS receives a TS315 message
- 2. TS315 is syntactically valid
- 3. TS315 is logically valid (No business rules violation)
- 4. The declaration is "pre-lodged"
- 5. AIS sends TS315V
- 6. G4 declaration is set to status [REGISTERED]
- 7. AIS receives a TS332 Presentation Notification message
- 8. The message is syntactically valid
- 9. The message is logically valid (No business rules violation)
- 10. AIS checks the arrival status of the declaration
- 11. The declaration is arrived
- 12. AIS forwards a TS328 registration message to the Trader
- 13. G4 declaration is set to next status in the processing

#### Alt 1 - Pre-lodged TSD is syntactically invalid

- 1. The process follows the core flow up to step 1
- 2. A TS315 message is syntactically invalid
- 3. AIS forwards an IM917 Syntax Error Notification message to the Trader















- 1. AIS receives a TS515 message for a request to move goods from one TS facility to another
- 2. The TS515 message is syntactically valid
- 3. The TS515 message is logically valid (No business rules violation)
- 4. The movement request is accepted by a Customs Officer
- 5. AIS sends a TS528 request acceptance message to the Trader
- 6. The receiving TS facility submits the TS501 (G5) message announcing the movement of the goods
- 7. The TS501 message is syntactically valid
- 8. The TS501 message is logically valid (No business rules violation)
- 9. The movement is accepted by a Customs Officer
- 10. AIS sends a TS508 G5 acceptance message to the Trader
- 11. The movement is completed

### Alt 1 - The movement request is syntactically invalid

- 1. The process follows the core flow up to step 1
- 2. The TS515 message is syntactically invalid
- 3. AIS sends an IM917 Syntax Error Notification message to the Trader

#### Alt 2 – The movement request is logically invalid

- 1. The process follows the core flow up to step 2
- 2. The TS515 message has logical validation errors
- 3. AIS sends a TS516 rejection message to the Trader

#### Alt 3 – The movement request is refused

- 1. The process follows the core flow up to step 3
- 2. The movement request is refused by a Customs Officer
- 3. AIS sends a TS516 rejection message to the Trader

## Alt 4 - The movement notification is syntactically invalid

- 1. The process follows the core flow up to step 6
- 2. The TS501 message is syntactically invalid



3. AIS sends an IM917 Syntax Error Notification message to the Trader

### Alt 5 – The movement notification is logically invalid

- 1. The process follows the core flow up to step 7
- 2. The TS501 message has logical validation errors
- 3. AIS sends a TS506 rejection message to the Trader

#### Alt 6 – The movement notification is rejected

- 1. The process follows the core flow up to step 8
- 2. The TS501 message (movement notification) is refused by a Customs Officer
- 3. AIS sends a TS506 rejection message to the Trader
- 4. The movement is incomplete and the Trader shall submit a new movement notification





## 4.2.1 Standard Customs Declarations (H1, H5, H6, H7, I1)

#### Core Flow (Happy Path) - Standard Customs Declaration

- 1. AIS receives an IM415 message (additional declaration type = A)
- 2. The message is syntactically valid
- 3. The message is logically valid (No business rules violation)
- 4. The declaration is evaluated as "arrived"
- 5. The declaration is accepted
- 6. AIS sends an IM428 acceptance message to the Trader
- 7. The declaration is Green routed

#### Alt 1 - The declaration is syntactically invalid

- 1. The process follows the Core Flow up to step 1
- 2. The IM415 message is syntactically invalid
- 3. AIS sends an IM917 Syntax Error message to the Trader

#### Alt 2 - The declaration is logically invalid

- 1. The process follows the Core Flow up to step 2
- 2. The IM415 message is logically invalid (Business rules violation)
- 3. AIS sends an IM416 rejection message to the Trader

#### Alt 3 – The declaration is evaluated as "non-arrived"

- 1. The process follows the Core Flow up to step 3
- 2. The declaration is evaluated as "non-arrived"
- 3. AIS sends an IM416 rejection message to the Trader

#### Alt 4 – RED/ORANGE Routing

- 1. The process follows the Core Flow up to step 6
- 2. The Declaration is Red/Orange routed
- 3. AIS sends an IM460 Control Notice message to the Trader

#### Alt 5 – CERTEX Certificate not finalised or under review

- 1. The process follows the core flow up to step 7
- 2. CERTEX reference is not finalised or under review
- 3. AIS sends IM099 "Declaration with DAFM" message to the Trader

#### Alt 6 - Decision to release the Goods - Entry Refused (Controls)

- 1. The process follows the Alt 4 up to step 3
- 2. The Goods cannot be released
- 3. AIS sends an IM451 release rejection message to the Trader

#### Alt 7 - Decision to release the Goods - Entry Permitted

- 1. The process follows the Core Flow up to step 7 or positive control results
- 2. The payment process is completed successfully
- 3. The Goods can be released
- 4. AIS sends an IM429 release notification message to the Trader

#### Alt 8 - Insufficient funds


- 1. The process follows the Core Flow up to step 7
- 2. Customs debt is due, Trader's Revenue account has insufficient funds
- 3. AIS sends an IM099 "Insufficient funds" information message to the Trader

#### Alt 9 - Timer for payment expired


- 1. The process follows the Alt 8 up to step 3
- 2. Trader has failed to fulfil their financial obligation to Revenue within a specified time-limit
- 3. AIS sends an IM451 Release Rejection message to the Trader

#### Core Flow (Happy Path) - Pre-lodged Standard Customs Declaration

- 1. AIS receives an IM415 message (additional declaration type = D)
- 2. The IM415 message is syntactically valid


