# 1. Introduction

## 1.1 Overview

This document describes the structures of the messages that the traders' automated declarations systems exchange with NCTS. It provides the documentation of the XML structures of the messages, including the XML elements of the messages, their description and additional technical information. The XSDs for these messages are also provided and they can be used for building the source code for the programs that interoperate with NCTS by producing and consuming messages.

## 1.2 Notations

The document uses two tables to describe each message:

- The summary table outlines the structure of the message. It lists only the high level elements of the message.
- The detailed description table, which includes all the XML elements of the message.

For each XML element the following information is included:

Column name	Description						
<b>LEVEL (L)</b>	The level of the given element in the hierarchy of all the XML elements of the message. One level one, there is only one, the so called "root" element of the XML document. Its name is the same as the identifier of the message						
<b>MESSAGE ENTITY</b>	The description of the message entity. The indentation visually represents the level of the entity in the hierarchy.						
<b>XML TAG</b>	The actual XML tag (element) for this entity.						
<b>REPETITIONS</b>	<p>The repetitions (cardinality) of the element. <b>OPT</b>	<p>Defines the optionality of the element, as follows:</p> <p>R: For required elements                      O: For Optional elements                      D: For elements that either required, optional or that cannot be completed</p>						

<b>TYPE</b>	The type of the element. The notation is explained in the examples below. Note that the type defined in this document is abstract. There can be more restrictions to the acceptable syntax of each element. These are described in details in the respective XSD file.
