## 1. Introduction

New Computerised Transit System Phase 5 (NCTS-P5) is Revenue's electronic transit system, which complies with the provisions of the Union Customs code (UCC). UCC stipulates that all communications between Trade and Customs must be electronic, and as such you will now also be able to upload supporting documents to Revenue via NCTS.

The EU Customs Data Model (EUCDM) forms the basis for every customs declaration. It defines how to complete a declaration and outlines the specifications required for IT systems. The documentation provided is based on the Union Customs Code (UCC) and the EUCDM. The D1, D2, D3 and D4 messages are mapped to the EUCDM version 6.1 with some minor deviations to allow for national requirements.

This guidance document is for the following purpose:

- Data Element structure, and their format
- Detailed description of each Data Element
- A guide to the details you will require before submitting a declaration

Consideration must be taken that there are numerous data elements to be input to complete a declaration. The format of the Transit Declaration now consists of four Levels of detail:

- Declaration Header
  - The data elements of the declaration Level contain information that applies to the entire declaration.
- Master Consignment Level
  - The data elements of the Master consignment Level contain information that applies to a transport contract issued by a carrier and direct contracting party. This header information is applicable for every Master Consignment Item in case of declarations and notifications referred to in column D of EUCDM.
- House Consignment Level
  - The data elements of the House consignment Level contains information that applies to the lowest transport contract issued by a freight forwarder, non-vessel or aircraft operating common carrier or agent or a postal operator. This header information is valid for every House Consignment Item in case of declarations and notifications referred to in column D in EUCDM.
- House Consignment Goods Item Level
  - The House consignment goods item Level is a sub-Level to the House consignment Level. The data elements of the House consignment item Level contain information that originate from different positions in the transport document referred to in the current House consignment. This Item information is applicable in case of declarations and notifications referred to in column D in EUCDM.

When there is one item on a transit declaration this information will be entered at Master Consignment Level and House Consignment Level.

When there are multiple items on a transit declaration then information will need to be entered at Master Consignment Level, House Consignment Level and House Consignment Goods Item Level.

There are 3 Levels of numbers for the Data Elements in the new format.

- Data Group Number is the title for each group. No declaration information is input on this Level.
- Data Element Level 1 which gives the details the first Level of information, for example 'Address'.
- Data Element Level 2 which gives the details of additional information to previous Level, for example Address details 'street name' and 'number' etc.
